FACILITY PERMIT POLICIES

APPLICATION FOR FACILITY USE

Group leader shall complete a facility form, provided by the Department, in duplicate.

Group leader must submit said form to Director for signature and approval. (permit is not valid unless stamped and signed.)

Original copy must be filed with department office. Copy to be retained by group leader.

Application for facility use should be made at least two weeks in advance.

ORDINANCES REGARDING PARK FACILITY USAGE-Violations will result in denial of future permits.

While using a park facility, no person shall:

Disfigure or remove any park property.

Litter facility grounds.

Make or kindle an open fire except in fireplaces or in areas provided for that purpose without written permission from Commission.

Lead or let loose animals in the parks and playgrounds.

Wash, polish or repair any motor vehicle on park property.

Consume alcohol or beer without receiving special permission prior to affair.

Conduct themselves in a disorderly fashion including the use of profane or abusive language.

Bet, gamble, in any form or maintain any gambling equipment.

Park unlawfully (park vehicle in other than designated area).

Drive motorcycle or moped vehicles in park areas aside from parking lot.

RESPONSIBILITIES OF PERMIT HOLDER

To relinquish rights to use facility at stated time on permit.

To have the copy of original stamped permit readily available and must display upon request.

To be aware of Township ordinances and abide by them
